#### **Updates**:

• There is an open <u>public comment forum</u> for 30 days on this DRAFT Noncontroversial Streamlining, Clarifying, and Regulatory Reductions to Chapter 115. In accordance with Governor Youngkin's <u>Executive Directive 1</u> to remove "regulations not mandated by federal or state statute, in consultation with the Office of the Attorney General, and in a manner consistent with the laws of the Commonwealth," the DBHDS Office of Human Rights reviewed the human rights regulations to identify noncontroversial amendments and developed a draft for consideration as fast track actions. Goals of the DRAFT revision to the Human Rights Regulations are to increase individuals' access to due process and rights protection, to make the regulations easier to

understand, and to improve administrative and program efficiencies to facilitate both provider compliance and increased availability of Human Rights advocates for direct involvement with individuals receiving services. Additional meeting date for Fact Finding Hearing- Petitioner vs. Gateway Home, Inc. in regard to HRR 12VAC35-115-150(E)

Members preset have agreed to meet March 5, 2025 at 10:00 virtually due to executive order 45 being in effect.

Fact Finding Hearing -Petitioner vs. District 19 Community Services Board (D19)

Review of rights read by Chairperson Edward Helton and additional rights. An opportunity for an open or closed meeting. Ms. Durose was informed that the LHRC would have a decision by Wednesday March 5, 2025.

Ms. Nicole Durose on behalf of Ms. Jones chose to have an open hearing.

Both parties were given 5 minutes of opening arguments.

Opening statement Nicole Durose stated represented client EJ. Stated that District 19 submitted false information to the courts and added additional information according to client EJ and went out of their way to have client hospitalized. She reported that District 19 misused the information and EJ was admitted to Central State Hospital.

Terrelle Stewart of District 19 Case Forensic Team. NGRI stated that District 19 acted on the information that the received and presented the information to the court based on the information.

Both provided 10 minutes for testimony.

Nicole Durose provided testimony that on District 19 violated EJ rights to include Dignity, Restrictions, Services and Participation and Abuse and Neglect.

District 19 provided testimony that District 19 EJ was non-compliant with services and with her treatment.

Closing statement from Nicole Durose disability Law Center of Virgina in Richmond, reported that client EJ tried to be compliant with all District 19 demands and based on information recommended an audit by an independent party.

Closing statement from District 19 followed all protocol and no human rights violations were committed. District 19 states that they had training in November 2023 of NGRI and all District 19 take updates on Human Rights training annually.

10:48 Chairperson Edward Helton thanked all parties for their testimony. Informed that the LHRC will deliver findings with 10 days and each party has the right to appeal the decision.

# **Closed Session**

At 10:50AM Bonnie Green made a motion to go into executive closed session, Charita Threat seconded and approved by all.

Deliberations regarding findings made in closed session.

# RETURN TO OPEN SESSION

At 1:23PM Charita Threatt made a motion to return to open session. Robyn Scott seconded. Approved by all.

Upon reconvening in open session, each member certified that, to the best of each member's knowledge, only private business matters, lawfully exempted from statutory open session requirements and identified in the motion by which the closed session was convened, were considered in the closed session, namely, to deliberate findings for fact-finding hearing.
